SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

- ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.
- ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. This consisted of the superintendent, high school principal, middle school principal, elementary principal, assistant principals, business official, director of facilities, and transportation supervisor. The district also conducted a parent survey (and incorporated parents ideas withing our district wide plan) and held a district wide community forum. We also conducted a district wide "Though Exchange" to ask district employees what they thought went well within the continued pandemic to try to sustain this positivity moving forward.

We are all set from a district standpoint to operate the opening of school in full capacity. Product, PPE, cleaning supplies, desk shields, have been purchased over the course of the past year and a half once the pandemic hit our region. A lot of planning has gone into this and subsequently continues. Additionally, to provide appropriate social distancing we will look to be purchasing and adding additional desks at the middle school to accommodate lunch space and additional classrooms.

Fountas and Pinnell literacy benchmarking, iReady ELA and Mathematical benchmarking, Wilson Reading Methodolgy Practices, and systematic AIS and RTI instruction in the classroom. Instructional support teams will be implemented in each the elementary school, middle school and high school to monitor students struggle and or academic success. Instructional support teams will all be led by all building psychologists. Additionally, we will be adding a Director of Curriculum to complete an instructional (curriculum audit) and to work directly with teachers, administrators in the classroom setting (what is and what is not working). We loos to add a transitional teacher to help with AIS at the elementary school, Class size-reduction, as well as the possibility to monitor students if there turns out to be a remote option. Last, academic support will be monitored for the students who will be attending before and or after school for additional support as well a a night school run by teachers at the high school due to the purposes of instructional loss over the course of the last year and a half.

We have devised a plan in collaboration with all stakeholders to conduct a plethora of summer enrichment programs (many of which have been addressed in the ESSER-2 and GEER-2) before and after-school programs that not only focuses on the struggling learner population, but offers enrichment to all students academically and in the arts. All programs will be monitored by the school principal's, director of curriculum, superintendent of schools, and the director of pupil personnel services.
